Despite the raging pandemic and closure of educational institutions during the year 2020-2021, students of the College found time to develop skills which has stood them and the institution in good stead.

In collaboration with the NGO Kolkata Ekatma, students maintained social distance and learnt to prepare sanitizers which they distributed in the College and which have been used in the College regularly to maintain necessary hygienic conditions.

In February, 2021, students of the College took part in an embroidery training under the aegis of the Jan Shikshan Sansthan, Ramakrishna Mission Narendrapur and Kolkata Ekatma, in the premises of Deshbandhu College for Girls. Students learnt to embroider beautifully and the products were displayed in exhibitions.

The institution has full-fledged Departments of Sanskrit and Bengali offering Honours and General courses. Additionally, Hindi is offered as an optional subject in the language group. In this context, the college library also houses many rare manuscripts and important books on Religion, Folk Cultures and the Sanskrit language and literature.

#### 1. Archive of Rare Books:

This serves to preserve our rich ancient Classical cultures for posterity. The books are housed in a special section of the institution's library and is one of the legacies of our institution. 2. Spreading COVID-19 Awareness to the Peripheral Regions: As an effort to bridge the gap between the centre and the margins during the first phase of the coronavirus pandemic, the college undertook the task of dissemination of awareness regarding the importance of vaccination against COVID-19 in the remote villages of the Darjeeling hills of Northern West Bengal. This was achieved through postering in these rural hill villages and direct outreach among the villagers. Miss Laden Sherpa, Assistant Professor in the Department of English, whose home is in the Darjeeling hills, in conversation with the Principal and the NSS Team of Deshbandhu College for Girls, Kolkata, took upon herself the task of preparing and distributing these posters and spread vaccination awareness through direct outreach.
