I. LEGAL FRAMEWORKS OF THE TWO INSTITUTIONS

Deshbandhu College for Girls, 45/C Rash Behari Avenue, Kolkata - 700026, West Bengal, India, represented by its Principal, Dr. Anita Chattopadhyay Gupta, hereinafter referred to as the FIRST PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in Office, representatives, administrators, and assigns), SmileTech & Aesthetics Dental Clinic, Kolkata - 700026, West Bengal, India, represented by its Orthodontist, Dr. Rishikanya Das, BDS, MDS, hereinafter referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in Office, representatives, administrators, and assigns). Both these Institutions will be hereafter referred to as Parties.

II. PURPOSE OF THE AGREEMENT

Both the Parties are pleased to enter upon an agreement to establish ties of cooperation in order to contribute to the healthcare facilities for the students, staffs and faculty of the College through the following but not limited to activities:

- 1. A discount of flat 20% on essential services like all types of dental extraction, root canal treatment (rct), denture and scaling to students, faculties and staff of Deshbandhu College for Girls.
- 2. A nominal consultation fee of Rs. 200/- only for all students, faculties and staff of Deshbandhu College for Girls.
- 3. Conducting Dental Awareness Camps and free dental checkups on campus from time to time.
- 4. Any other activity that is mutually agreed upon and is beneficial to both.

HII. TERMS AND EXPIRATION OF THE AGREEMENT

Any of the two Parties can choose to terminate the linkage at any time with a prior written notice of 6 (six) months.

- 2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
- 3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MOU or any subsequent associated agreement informally.
- 4. Neither party can misuse this MOU by involving the name of the other without the written consent letter from the other party.
- 5. There will be no financial involvement by neither of the Party.

VI. DISPUTES

No legal relationship between the two Institutions is implied through this

If any dispute arise in respect of the MOU, in that case both the Institutions will discuss and settle the matter amicably.

This document of understanding shall uphold the ethos of holistic development of the society, and shall not in any way impede or affect each of the participatory institution's individuality and distinctiveness, by any way whatsoever.
