## I. FRAMEWORKS OF THE TWO INSTITUTIONS

Deshbandhu College for Girls, 45/C Rashbehari Avenue, Kolkata - 700026, West Bengal, India, represented by its Principal, Dr. Anita Chattopadhyay Gupta, hereinafter referred to as the FIRST PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in Office, representatives, administrators, and assigns), Uluberia College, Uluberia, Howrah - 711315, West Bengal, India, represented by its Principal, Dr. Debasish Pal, hereinafter referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in Office, representatives, administrators, and assigns). Both these Institutions will be hereafter referred to as Parties. This Memorandum of Understanding is a framework for specific collaborative initiatives to be developed between the two institutions.

## II. AREAS OF COLLABORATION


Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as Institutions through the following but not limited to activities :


1. Online sharing of innovative ideas in Teaching-Learning and e-Governance ;
2. Collaborative research ;
3. Sharing of scientific information on areas of mutual interest ;
4. Faculty and student mobility ;
5. Library sharing ;
6. Joint national/international seminars/workshops ;
7. Other academic collaboration, including publications.
8. Any other activity that is mutually agreed upon and is beneficial to both.

## III. DEVELOPMENT OF INITIATIVES

Areas of cooperation will be defined between the two Parties throughout the duration of the MOU and further agreement of academic agreements of academic collaboration may result for specific collaborative activities.

Neither institution shall have any financial commitments to each other, nor through this MOU, real or implied. Both the parties agree, however, to endeavour to secure Government, Corporate or other third-party funding where possible in order to support the collaborative activities covered by the agreement.

#### IV. CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

Both the Parties shall respect and retain confidentially in each/any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the Colleges, and not any other/commercial interest.

This MoU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

#### V. DURATION, AMENDMENT AND TERMINATION OF THE MOU

This MoU will remain in effect for a period of 5 (five) years from the date of signing of the MoU. It may be amended at any time by mutual agreement and in writing as an addendum. No legal relationship between the two institutions is implied through this agreement. Either party may terminate this MoU at any time and for any reason by giving the other party at least 3 (three) months written notice of its decision.

#### VI. NON-EXCLUSIVITY

This agreement is a non-exclusive agreement, and both Parties remain free to enter into similar agreements with third parties.

#### VII. SPECIAL PROVISIONS

1. Each Party will take approval from the other Party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent letter from the other party.

#### VIII. DISPUTES

No legal relationship between the two Institutions is implied through this linkage.
