


**EVENT REPORT**  
**A COLLABORATIVE ACTIVITY UNDER MoU WITH KASHIPUR MICHAEL MADHUSUDAN COLLEGE**



## I. LEGAL FRAMEWORKS OF THE TWO INSTITUTIONS

Kashipur Michael Madhusudan Mahavidyalaya, Kashipur, Post- Panchakote Raj, Dist- Purulia, West Bengal-723132 India, represented by its Principal, presently, Dr. Bibhas Kanti Mandal, hereinafter referred to as the FIRST PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in Office, representatives, administrators, and assigns), and Deshbandhu College for girls, 45/C Rashbehari Avenu, Kolkata-700026, West Bengal, India, represented by its Principal, presently, Dr. Anita Chattopadhyay Gupta, hereinafter referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in Office, representatives, administrators, and assigns). Both these Institutions will be hereafter referred to as Parties.

## II. PURPOSE OF THE AGREEMENT

Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as Academic Institutions through the following but not limited to activities:

1. Joint teaching and learning and research projects
2. Collaboration in the area of academic publications
3. Visit, training and exchange of faculty and students of suitable stream(s)
4. Joint sharing of Laboratory and Library facilities of the Colleges
5. Co-hosting/organizing and participation in National/International conferences, seminars/webinars, symposia and workshops including student seminar/ paper/ poster presentations.
6. Any other activity that is mutually agreed upon and is beneficial to both the Institutions.

## III. EXECUTION OF AGREEMENT

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both Parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, period of the sub-agreement will be in effect, and administrative responsibility within the purview of each Institution.

## IV. TERMS AND EXPIRATION OF THE AGREEMENT

It is understood that this agreement will come<sup>3</sup> into effect after being signed by both Parties and will be established for a minimum period of 5 (five) years. After the expiry of five years, it will automatically affect the terms of activities ongoing at the time of notification of amendment, termination/expiration, unless otherwise agreed upon between the two Parties.

Any additions, alterations, changes, deletions to this document must be approved by the representatives of both the Parties. All notices shall be in writing and shall be directed to these representatives.

Any of the two Parties can choose to terminate the linkage at any time with a prior written notice of 6 (six) months to each other.

## V. NON-EXCLUSIVITY

This agreement is a non-exclusive agreement, and both the Parties will remain free to enter into similar agreements with any third party.

## VI. SPECIAL PROVISIONS

1. Each Party will take approval from the other Party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall take utmost care to ensure the smooth and efficient implementation of the programs for the betterment of academic interest.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MOU or any subsequent associated agreement informally.
4. Neither party can misuse this MOU by involving the name of the other without the written consent letter from the other party.
5. There will be no financial involvement/liability/obligation by neither of the Party.
6. This collaboration will respect Intellectual Property Rights (IPR) and any other intellectual matter developed by the collaborative efforts of the two Parties shall be retained by them.
7. All collaborative activities shall be guided, directed and impelled by the greater academic interest of both the Parties, and not by any other/commercial interest.

## VII. DISPUTES

No legal relationship between the two Institutions is implied through this linkage. If any dispute arises in respect of this MOU, in that case both the Institutions will discuss and settle the matter amicably and it's beyond the purview of any Court of Law.
